About the Faculty

The mission of the Faculty of Law and Administration of the University of Lodz is to build scientific and didactic excellence so as to prepare new generations to serve in a democratic state governed by the rule of law, educate in the spirit of the highest ethical values, and undertake activities aimed at the development of science and society. Following the motto “law is the art of applying what is good and right”, we engage in activities for the benefit of the whole society – from cooperation with the local environment to international projects.

We initiate research to increase social security, analyse issues that will challenge legislation in the future and propose solutions allowing a step towards the future.

Faculty of Law and Administration of the University of Lodz consists of 23 departments, which allows for comprehensive specialisation.

The most important research areas include:

- Labour law – including AI, atypical employment relations, migration, global trade;
- International law – human rights, humanitarian law, law of war, equality, new technologies, environmental protection, public procurement, EU;
- Tax law – cooperation with IBFD, NL; EUCOTAX since 2010; organiser of the only EATLP congress in Poland.

WhistlePro 2020-2021 (Visegrad Grant, No 21930021)

A research project focusing on the protection of employees who reveal irregularities or violations of the law in their organisations, both in the public and private sectors (whistleblowing).

TechLaw Clinics 2019-2022 (ERASMUS+ 2019-1-FR01-KA203-062630)

The objective of the project is to familiarise law students with the subject of new technologies, and STEM students with the subject of law. Synergy of didactics and practice (workshops, moot courts, law clinic). Consortium: Catholic University of Lyon (FR) – leader, Jagiellonian University (PL), Radboud University in Nijmegen (NL) and Amedeo Avogadro University of Eastern Piedmont (IT) and Faculty of Law and Administration of the University of Lodz.

Philip Jessup Moot Court Competition

Teams of the Faculty of Law and Administration of the University of Lodz have represented Poland in Washington 6 times in the last 8 years (2015, 2017, 2018, 2019, 2021, 2022). The biggest success was the title of 8th Best Oralist awarded in 2019. Faculty of Law and Administration of the University of Lodz teams has also taken part in other moot court competitions: e.g. Tedlers International Law MCC, Nelson Mandela World Human Rights MCC, Manfred Lachs Space Law MCC.
