



## Regulations of the University Children's Day

**organised on 2 June 2023 on the Academic Sport Association premises, ul. Lumumby 22/26, 91-404 Lodz**

### **§1. General provisions**

- 1) The University Children's Day, hereafter referred to as the Picnic, will be held on 2.06.2023 from 15.00 to 19.00 on the Academic Sport Association premises, ul. Lumumba 22/26 in Lodz, within the area designated by the landowner (map attached).
- 2) The University of Lodz (UL) assumes the role of the primary organiser of the Picnic, while the Academic Sport Association (AZS), the Polish Teachers' Union (ZNP), and the Independent Self-Governing Trade Union Solidarność (NSZZ Solidarność) participate as co-organisers, hereinafter jointly referred to as the Organiser.
- 3) The Participants of the Picnic are people connected with the University of Lodz (mainly employees) together with children, grandchildren / those under their care.
- 4) Participants in the Picnic are obliged to familiarise themselves with these Regulations. Entry to the AZS premises implies acceptance of these Regulations.
- 5) The Picnic Regulations, hereinafter referred to as the Regulations, are addressed to all persons who will be staying on the AZS premises during the Picnic, ul. Lumumba 22/26 in Lodz, at the venue of the Picnic. Every individual present at the venue of the Picnic throughout its duration is required to adhere to the provisions stated in the Regulations, as well as follow the instructions provided by the Organisers and the security personnel.
- 6) The Organiser of the Picnic will provide the Participants with the following services throughout the event: organizational and informational assistance, access to sanitary facilities, maintenance of order, presence of identifiable security personnel wearing distinct



attire, as well as ensuring safety and medical protection. The medical aid station is located in front of the AZS building, next to the sports stadium.

- 7) The Organiser shall not be liable for any incidents or consequences resulting from the Event Participant's ignorance of and failure to comply with the rules contained in these Regulations.

## **§2. Rights and obligations of Picnic Participants**

- 1) Participation in the Picnic is free of charge and available to individuals associated with the University of Lodz, primarily employees, as well as their children, grandchildren, or those under their care, with the exception specified in item 11 of this section.
- 2) Minors are permitted to attend the Picnic and enjoy the provided attractions solely under the supervision and responsibility of their parents, grandparents, or legal guardians, who must accompany them throughout the event.
- 3) All Participants are required to behave in a manner that does not jeopardize the safety of others, specifically by observing health and safety rules and complying with the provisions stated in these Regulations.
- 4) Picnic Participants must comply with the instructions provided by the Organisers and the security service.
- 5) If equipment such as inflatable obstacle courses or other specialised equipment is placed on the Picnic premises, it may only be operated by authorised persons or under their direct supervision.
- 6) Picnic Participants are strictly prohibited from bringing, possessing, and using weapons or other hazardous objects, explosives, pyrotechnic products, flammable materials, fire hazardous materials, as well as bringing and consuming alcoholic beverages, intoxicants, or psychotropic substances within the Picnic area.
- 7) Smoking of tobacco products and electronic cigarettes is strictly prohibited on the AZS and Picnic premises.
- 8) Engaging in any form of commercial, promotional, advertising, or political agitation activity on the Picnic premises without permission from the Organiser is strictly prohibited.
- 9) The following individuals are not allowed in the Picnic premises:

- a) under the influence of alcohol, narcotic drugs, psychotropic drugs or other similarly acting agents,
- b) behaving aggressively, provocatively or otherwise posing a threat to the safety of Participants, the Organiser or public order.

10) In addition, it is prohibited to:

- a) use the equipment on the Picnic premises in a manner contrary to its intended use and damage the equipment used for the organisation of the Picnic and located on the Picnic premises, including signage and information boards,
- b) enter fenced off areas or stands without prior permission from the Organiser or the stand supervisor,
- c) block roads and passageways with cars, bicycles or other vehicles or equipment, under pain of towing the vehicle at the owner's expense, or removal of the equipment by the Organiser's security service,
- d) display any behaviour that provokes or incites disorder or security that may be conflictual, offensive or degrading to others,
- e) engage in any action likely to endanger the life, health or safety of persons on the Picnic premises, in particular the throwing of any objects.
- f) litter in the Picnic area.

11) The Picnic Organiser reserves the right to deny entry to individuals who fail to comply with §2 item 3.

12) Persons who do not comply with the provisions of items 2-10 will be removed by the security services from the Picnic premises.

13) In the event that a fire or other danger to health, life and property is noticed, Participants should:

- a) immediately notify the security service or the Organiser,
- b) comply with the instructions of the security service or the Organiser,
- c) leave the Picnic premises as indicated by the security services or the Organiser.

14) If safety areas are designated by the Organiser, Participants should only use the designated areas.



15) The Organiser shall not be held liable for theft, loss, or damage to valuables, money, or other belongings of Picnic Participants that occur due to the Participant's own fault.

### **§3. Use of image**

- 1) The Organiser and the persons it appoints may capture photographs and recordings of the event for documentation purposes as well as for promotional and advertising use related to the Organiser.
- 2) The likeness of individuals present on the Picnic premises may be recorded and subsequently shared for documentation, reporting, advertising, and promotional purposes.
- 3) The University of Lodz reserves the right to utilize the recorded images of Picnic Participants during the event for promotional, informational, and documentation purposes
- 4) Picnic Participants acknowledge that their entry to/participation in the event constitutes their unpaid consent for their image to be recorded, photographed, filmed, or otherwise captured in connection with the Picnic, and for the captured image and voice during the event to be broadcast, distributed, or shown in connection with any program depicting the event. The legal basis for the processing of the image is the permission to disseminate the image, as referred to in Article 81 of the Act on Copyright and Related Rights.

### **§4. Information on personal data processing**

- 1) The Controller of personal data is the University of Lodz with its registered office at ul. Narutowicza 68; 90-136 Łódź.

- 3) The personal image data you provide is processed for promotional, information and documentation purposes.
- 4) Your personal data is processed based on your consent to its processing and you have the right to withdraw your consent at any time without affecting the lawfulness of the processing carried out prior to the withdrawal of your consent.
- 5) Your personal data will be stored for the period necessary and required by law.



- 6) In relation to the processing of your personal data, you have the right to access your personal data, to rectify, erase or restrict the processing in justified cases, to lodge a complaint to the supervisory authority, which is the President of the Data Protection Office with its registered office in Warsaw ul. Stawki 2.
- 7) Processing of personal data is carried out pursuant to Article 6(1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (general data protection regulation; OJ EU L. 2016.119.1) - "GDPR".

#### **§5. Final provisions**

- 1) The Organiser reserves the right to introduce and change the course of the Picnic for justified reasons, e.g. force majeure (e.g. weather conditions, general hazards arising).
- 2) The Organiser reserves the right to cancel the Picnic without prior notice, and shall not be held accountable for any compensation in such cases.
- 3) If there is any doubt regarding the content of the Regulations, the Organiser assumes sole responsibility for providing clarifications.

- 5) The University of Lodz bears no responsibility for any events or consequences arising from participants' lack of awareness or failure to comply with the rules outlined in these Regulations.
- 6) The Organiser reserves the right to make modifications to these Regulations, including safety guidelines, while ensuring that the provisions remain unaltered.
