

FEES FOR THE USE OF PLACES**IN THE DORMITORIES OF THE UNIVERSITY OF LODZ AND THE RULES OF THEIR APPLICATION****1. RATES FOR ACCOMMODATION FEES for full months:****II DORMITORY**

- a) UL students/doctoral students who have resided in UL Dormitories for more than 20 full months will be eligible for a 10% discount. The relief will be granted upon application by the student/doctoral student.
- b) UL students residing in the University of Lodz Student Dormitories and receiving a maintenance grant may request an increase in the grant in accordance with the amount specified in Appendix 9 of the Regulations for Scholarships for University of Lodz Students and Doctoral Students.
- c) Discounts for the children of residents and the option to make advance payments will remain in effect. Detailed information is given in Chapter 4 § 18.
- d) The provisions outlined in items a to c do not pertain to students from other Higher Education Institutions.

2 SECURITY DEPOSIT

- **II, III, V, VII, VIII, IX, X, XI, XIII, XIV DORMITORIES** - this is the equivalent of the two-month fee for a place in a room (2- or 3-person) in a given UL Dormitory.

The provisions set forth in Appendix 14 to the Regulations for Allocation and Use of Places in the Student House of the University of Lodz shall apply.

4. APPLICATION OF ACCOMMODATION FEES

- a) The monthly fee for a Dormitory place is required to be paid by the 26th of each month into the designated Dormitory's account, with the payment date determined as the day when the transfer is credited to the bank account of the Dormitory where the SJPdC student/doctoral student/course participant resides.
- b) Throughout the calendar year, the daily conversion rate applies during both the check-in and check-out months;

- c) A student who has made an excess payment for the dormitory can request a refund by submitting a completed application for refund of overpayment (Appendix 10) to the respective Dormitory;
- d) If the fee is not paid on time, a penalty of PLN 10 will be imposed for each month of delay, provided that the outstanding debt exceeds PLN 10;
- e) A resident's temporary absence from the Dormitory does not exempt them from the obligation to pay the fee;
- f) The regulations outlined in points A to E also extend to the non-working spouse of a UL student, a UL doctoral student, and their children, as well as to students from other Higher Education Institutions situated in Lodz, with the condition that the accommodation fee includes an additional VAT charge;
- g) As for the employed spouse of a student or doctoral student at the University of Lodz, the regulations described in items a to e apply, with the exception that the spouse is required to pay an accommodation fee for the University of Lodz Dormitory, which includes an additional charge of PLN 50 plus VAT;
- h) Individuals residing alone in a two-bed or three-bed room, or two occupants in a three-bed room upon the departure of their roommates, are obligated to relocate to another room where the available spaces are not fully occupied;
- i) In the event of non-compliance with the condition outlined in item h, individuals who have been residing alone in a double or 3-person room for more than 15 days, or two occupants in a 3-person room, are obliged to pay a fee in the specified amount below:
 - double room for 1 person - 150% per person,
 - 3-person room for 2 people - per person as for a place in a double room in a given Dormitory,
 - 3-person room for 1 person - 200% per person;
- j) To live independently in a double room, a 3-person room, or with another person in a 3-person room, a student, doctoral student, or course participant must submit an application for independent living to the Dormitory manager, as specified in Appendix 8 of the Regulations for the Allocation and Use of Places in the Students' Dormitory of the University of Lodz. In the application, the student/doctoral student/course participant agrees to pay a higher fee for the occupied room. Permission for a student to reside independently in a 2- or 3-person room or to share a 3-person room with two individuals is granted solely in cases where there are no applications from SJPdC students or listeners seeking accommodation in the Dormitory.
- k) A student, doctoral student, or course participant who falls behind on payments for two months forfeits their right to reside in the corresponding student house.

5. FINAL PROVISIONS

- a) the amount of rates for the use of a place in the Dormitory is determined by the Rector in consultation with the University Students' Government Council and University Doctoral Students' Government Council, information on changes in the rates of fees for accommodation in the Dormitory is published on the University of Lodz website.
- b) The rates for Dormitory space utilization may be revised throughout the academic year.
- c) In cases where the standard fee conversion rate is employed, the fee amount is rounded up to the nearest whole zloty.
- d) During emergency situations, students are expected to fully comply with the orders and other legal directives issued by the University Authorities.
